ORDER

- (iv) Accreditation guidelines for NGOs

- (v) Sanction for advertising the RFP in two leading Malayalam & English dailies debiting the expenditure from the Head of Account 2235-02-104-83(P) in the current year Budget.
- (vi) Formation of a Special Cell in the Directorate of Social Justice by posting one Senior Superintendent and two clerks on working arrangement basis for the activities of the NGO policy & Accreditation process.
