ORDER

As per the Government Order read above, administrative sanction was accorded for the on-going schemes of Kerala State Women's Development Corporation for the financial year 2014-15 for an amount of ₹ 6,50,00,000/-. Now, the Managing Director, Kerala State Women's Development Corporation, as per his letter read above, has requested to release the allocated fund of ₹650 lakh for the implementation of the on-going schemes of KSWDC.

(2) Government have examined the matter in detail and are pleased to accord sanction for the release of an amount of ₹ 3,25,00,000/- (Rupees three crore and twenty five lakh only) under the head of account 2235-02-190-99(P) to Kerala State Women's Development Corporation for the year 2014-15 subject to the following terms and conditions.

- The amount shall not be parked in Banks/Financial Institutions other than Treasuries. The instructions stipulated in Circular No. 75/2009/Fin dated 29.08.2009 shall be scrupulously followed.
- The instructions in Circular No. 84/2008/Fin dated 09.12.2008 shall be scrupulously followed.
- The amount shall be utilised during the current financial year itself and for the purpose for which the same has been sanctioned. Unspent balance shall be resumed to Government account without fail.
- The Corporation shall furnish duly authenticated detailed component wise statement of expenditure, Utilisation Certificate in form no. 44 KFC and latest audited accounts while forwarding the proposal for further releases.
- The amount shall be transfer credited to the non interest bearing TSB account and has to be released as per actual requirements only.
