Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (Central Act 1 of 1996) has been repealed by the Rights of Persons with Disabilities Act, 2016 (Central Act 49 of 2016). The State Co-ordination Committee was constituted under section 13 of the said Act which was issued as G. O. (P) No. 19/12/SWD dated 23rd March, 2012 and published as S.R.O. No. 190/2012 in the Kerala Gazette Extraordinary No. 594 dated 24th March, 2012. The term of the said committee has expired. Section 66 of the Rights of Persons with Disabilities Act, 2016 provides for the constitution of a body known as State Advisory Board on disability to exercise the powers conferred on and to perform the functions assigned to it under the Act. Hence the Government have decided to constitute a State Advisory Board on disability and to nominate its members.

The notification is intended to achieve the above object.
