ORDER

As per the Government Order read as first paper above, Government have issued operational guidelines for the implementation of Cochlear Implantation scheme named "Sruthitharangam" in the State. As per letter read as 3rd paper above, the Kerala State Social Security Mission has informed that they invited e-tender for the purchase of Cochlear Implants for one year from the date of signing agreement with company. Accordingly they invited technical bid and financial bid. The financial bids were opened by the Departmental Purchase Committee constituted by Government order read as 2nd paper and Kerala Social Security Mission informed that Med-el India Private Limited, New Delhi has been selected as they are L 1. Further the Committee held price negotiation with Med-el India Private Limited and the Company has agreed to reduce the quoted price of implant to Rs.4,45,000/- So Kerala Social Security Mission has requested to issue necessary order to purchase cochlear implants under the scheme from Med-el India Private Limited, New Delhi.

(2) Government examined the matter and are pleased to issue administrative sanction for the purchase of Cochlear implants from Med-el India Private Limited, New Delhi with following conditions.

(a) Med-el India Private Limited, New Delhi shall supply the Cochlear implants for an amount Rs.4,45,000/- (Four Lakh forty five thousand only) per each implant on the basis of technical, infrastructure as well as expert support, terms and conditions as per the negotiation held with the purchase committee.

(b) Kerala Social Security Mission is authorised to execute appropriate agreement with Med-el India Private Limited, New Delhi for the implementation of the scheme incorporating all necessary terms and conditions mentioned above.

(c) The existing operational guidelines for the implementation of Cochlear Implantation scheme as per G.O(Ms)No.33/2014/SJD dated 5.5.2014 shall continue for the current financial year also.
