DEPARTMENT OF SOCIAL JUSTICE GOVERNMENT OF KERALA

1.0 BACKGROUND

The Social Justice Department (Hereinafter referred as SJD) Government of Kerala is responsible for social protection activities, providing security to the vulnerable and socially dis empowered. In implementation of its mandate, SJD operates care homes, implements various schemes and welfare programmes for the persons with disabilities.

2.0 PROJECT

At present only two Govt run care homes are functioning in the State for adults with intellectual disabilities under Social Justice Department. One for men at Thavanur, Malappuram District (Pratheeksha Bhavan) and the other for women at Thrissur (Prathyasa Bhavan). Even though new requests for admission to these homes from various agencies are received. SJD is not in a position to accommodate them as they have reached the limits of sanctioned capacity. There is a felt requirement for more such homes. To overcome this challenge, the SJD intends to start coordinating with NGOs for running Care homes for Mentally Challenged. This project is intended to achieve this objective.

The amount will be allotted to a maximum of 50 persons in the following manner:

3.0 SCOPE OF WORK FOR THE APPLICAN

Financial assistance will be provided to credible NGOs for starting the Care Homes as per the project proposal and guidelines approved by Government. The proposals received will be sent to District officers to verify the credentials of the NGOs and on the basis of the recommendations from District Social Justice Officer concerned, the agencies whose proposals satisfy the eligibility criteria will be invited for a technical presentation about the intended proposal, its implementation, budget and output. After technical evaluation on different parameters an eligible NGO will be selected for implementation of the project.

4.0 ELICIBLE APPLICANTS FOR EOI

- 1. Credible NGOs having approved license under RPwD Act 2016
- 2. Having experience in running similar nature of institutions at least for a period of 3 years
- 3. Having sound financial back ground
- 4. The managing committee / Office bearers of the NGO must have good social status and reputation
- The NGO has its own building and the building should have a plinth area of 7000 Sq ft and have infrastructure facilities for running the home
- The NGOs/Organization should have registered office in Kerala and area of work also should be within Kerala geographically.
- The proposed building and spaces should have proper accommodation facilities, sanitary arrangement and all other conditions mentioned in the scheme.

5.0 CONTENTS OF EOI

· 5.1 NUMBER OF COPIES AND MODE

The information to be submitted by the applicants in their EOIs is described below in the checklist. The Applicant shall place one (1) original + one (1) copy of the Expression of Interest in a sealed envelope and send it directly to the Director of Social Justice.

5.2 CHECKLIST

- Part 4- Concept note regarding the project clearly mentioning how the project is proposed to be implemented

The EOI organized as above, shall be placed in a sealed envelope, with the following inscription: Proposal for running Care Homes for Persons with Intellectual Disabilities in collaboration with Social Justice Department to start new "Pratheeksha Bhavan" for the Mentally

Challenged men.

6.0 LAST DATE OF SUBMISSION OF EOI:

The Applicants are required to submit their Expression of Interest latest by 17.00 hrs, on 20/05/2022 to the Director of Social Justice, 5th Floor, VikasBhavan, Thiruvananthapuram 695011.

7.0 TECHNICAL COMMITTEE MEETING:

The technical committee meeting will be held on 30/05/2022 at 15.00 hrs in the Director's Chamber Department of Social Justice, 5th Floor, Vikas Bhavan, Thiruvananthapuram 695033 or online, as decided by the Director of Social Justice. The agenda of this meeting will include 5 minutes power point presentation by the applicants about the project proposal. If the number of applications are more than one, then committee will take a decision based on experience of NGOs/Organization in this field, ideas in concept paper and cost-output analysis.

Criteria for Evaluation

The proposals received from the applicants within the time period will be vetted by a Technical Committee constituted for the purpose and headed by the DSJ. The applications will be scrutinized with the scheme details mentioned in SJD/1592/2020-D2 and the GO(Rt) No.554/2021/SJD dated 10/08/2021. Those who fails to fulfill the conditions prescribed in the scheme details will not be eligible for selection.

The broad framework of technical presentation by the applicant will be as follows.

- 1. Description about the NGO.
- 2. Present activities in rehabilitation (Disability sector)
- 3. Expertise in institutional rehabilitation for intellectually challenged.

- 4. Strategy for the implementation of the Pratheeksha Project.
- 5. Details of land and building available exclusively for this project.
- 6. Infrastructure facilities available in tune with scheme criteria.
- 7. Suggestions on improvements/ innovation in Pratheeksha Project within the budgetary limit.
- 8. Details of any other collaboration projects with government departments. Awards, achievements and recognition of the NGO.
- 9. Details of success stories in uplifting the Persons with Disabilities.
- 10. Any other remarks.

The presentation (PPT) will be limited in 10 slides (each of the above criteria requires a slide)

8.0 DISCLAIMER

Though adequate care has been taken in the preparation of this Expression of Interest Document, the Applicant should satisfy himself that the Document is complete in all respects. It shall be the responsibility of the Applicant to furnish all claims that the applicant puts forth in their EoI.
